Where was the trash originally from?
 A landfill in Islip, New York

Mexico sent out its navy of four ships, two planes, and a helicopter.

9. Why did the man in Little San Salvador want the trash? What happened?

He wanted to use the garbage to build up the island so he could build a resort on top of it. The Bahamian government sent out its defense force and did not allow this to happen.

10. What happened when the barge neared the Florida Keys?

The Florida government sent of federal environmental agents in white suits and protective breathing masks to look for hazardous materials. They found that it was ordinary garbage. The barge still was not allowed to stop.

11. What happened after two months?

Islip said that they would take the garbage back. They would put out yellow ribbons to welcome it.
